A. Re-Certification of Fiscal Year 2020 (FY20) Budget

- ROBERT LIONETTE MOVED TO RECONSIDER THE JANUARY 3, 2019 VOTE TO CERTIFY THE UP ISLAND REGIONAL SCHOOL DISTRICT BUDGET; KATE DEVANE SECONDED; MOTION PASSED UNANIMOUSLY: 5 AYES, 0 NAYS, 0 ABSTENTIONS: ROBERT LIONETTE—AYE, ALEX SALOP—AYE, KATE DEVANE—AYE, ROXANNE ACKERMAN—AYE. SKIPPER MANTER—AYE.
- The driving factor was the reduction of the health/dental insurance rate increase from 10% estimated to 0%. However, health insurance costs were also driven by changes in staff and types of plans, i.e. retirees, new hires, individual vs. family plans, etc. The UIRSC examined the changes in detail on Lines #368, 369, 370, 538, 539, 540, as well as Districtwide changes and the Superintendent's Shared Services Office budget. The change would drop the operating budget from a 4.56% to a 3.97% increase and the assessed budget from same 4.47% to 3.88%.
