Call to Order

The meeting of the Martha's Vineyard Regional High School Committee (MVRHSC) was called to order at 5:20 PM.

Tisbury Middle School Use of MVRHS

(Agenda Item #II)

Vice Chair Amy Houghton thanked the MVRHS and the community for their support. The purpose of this Emergency Meeting is to inform everyone of the Tisbury Middle School move to the MVRHS.

The MVRHS has designated 7 classrooms (and students and staff designated bathrooms) for the Tisbury Middle School in the 200 hallway, which is the middle section of the School. The students will have lunch in the Culinary Dining Room. Use of the gym for Physical Education (PE) is still being reviewed. The YMCA has offered their facility to Tisbury students.

High school student hours will remain the same. Tisbury Middle School students would like to keep their previous schedule from 8:10AM to 2:40PM. High school and middle school hours will be staggered.

There is a meeting tomorrow with Transportation to work out the bus details. High school and middle school students will not be on the same bus. Tisbury students will be dropped off at the Culinary Dining Room entrance.

Tisbury Principal John Custer thanked MVRHS, as well as parents and community members for accommodating Tisbury Middle School.

MVRHS and Tisbury will devise a formula to help with costs incurred. In addition to providing teaching staff (plus a nurse, cafeteria help and a secretary), Tisbury is planning on paying for space usage and any additional MVRHS subs and/or staff. Mr. Skip Manter

emphasized that Tisbury should pay a fee for the space. However, Ms. Janet Packer protested that MVRHS did not pay for Tisbury School space in the 1970's while the MVRHS facility was dealing with asbestos issues.

Messaging logistical information to high school students and families was discussed. Tisbury Middle School student isolation from MVRHS students will be emphasized. Entrance and exit messaging is a priority. MVRHS student class meetings will be held on: parking, space and hosting issues.

The MVRHSC briefly noted the issue of the MVRHS facility health and wellness and a joint letter from staff and the MVRHSC was proposed (see below: Tasks).

Ms. Kathryn Shertzer suggested this could be an inspiring opportunity for high school students to have a positive influence on middle school students.
