A. Donna Lowell-Bettencourt - West Tisbury School

The West Tisbury fifth grade won the 2019 Marine Debris Creative Advocacy Competition Silver Award.

- The Town received a letter of interest on the Chilmark School heating proposal. At the moment the Principal's Office, the kindergarten/first grade, art and pre-school classrooms had no heat. Alan Forest and Cole Powers would work on the problem over the holiday break.

A. Possible Fiscal Year 2021 (FY21) Budget Certification

B. Expenditure and Revenue Report (See documents on file.)

Not much had changed in the last month. Revenues were up to date with assessments paid on time. The Other Post Employee Benefits (OPEB) commitment to the Trust was paid.

F. Review of Circuit Breaker Account & Law (See documents on file.)

A Circuit Breaker balance of \$144,798 was in a special account. It could be used to offset Special Education expenses in the budget or left to revert to Excess and Deficiency (E & D). Business Administrator Amy Tierney reported that the Massachusetts Department of Revenue (DOR) had required Circuit Breaker funds be closed out the previous year.

- The high balance and revenue came from reimbursement for a residential placement that lagged a year behind (the student having left the School).
- It was suggested that since the taxpayers had paid for the first year (when no reimbursement was paid due to the one-year lag) this year's funds should be returned to the Towns.
- Offsetting the Budget with such a large amount, which was one-year-only revenue would put the UIRSD at a disadvantage for the FY22 budget.
- Head of Chilmark School Susan Stevens could use the funds for a one-time purchase for first and third grade Fontas & Pinnell Reading curriculum units. She also was stretching the Chilmark Special Education teacher time with a half-time Education Support Professional (ESP).
- The Principals advocated for a Special Education Stabilization Fund to cover unexpected expenses: hospitalizations, new students, equipment, special services, residential tuitions, etc. (see 9/16/19 Minutes p.1-2 #IV A). Such a stabilization fund could be subsidized with residual Circuit Breaker revenues allowing them to be "banked" for future Special Education use.
- Although there were no current students eligible for Circuit Breaker revenues school populations were unpredictable and special needs continued to increase.
- Skipper Manter suggested the Circuit Breaker funds be returned to the Towns and the article funded at the same amount as the return.
- The Martha's Vineyard Regional High School (MVRHS) was also discussing such a fund.
- KATE DEVANE MOVED TO DRAFT A WARRANT ARTICLE ON THE ESTABLISHMENT A SPECIAL EDUCATION STABILIZATION FUND; ROXANNE ACKERMAN SECONDED; MOTION PASSED: 3 AYES, I NAY-SKIPPER MANTER, 0 ABSTENTIONS. Mr. Manter was in favor of the fund but wanted to see a dollar amount.

C. Transportation Budget (See documents on file.)

This Draft was not yet finalized. It contained a number of different methodologies for cost reimbursement. Despite higher costs, the increased number of runs reduced local costs.

D. Capital Warrant Articles

It was hoped the Chilmark window project would save funds by completing two final phases during the summer vacation.

A. Possible Fiscal Year 2021 (FY21) Budget Certification (See above #IV.)

If all the capital and SRO articles were included school spending increase was about \$1,000,000.

- There was disagreement over the approximately \$108,000 E & D offset to the Reserve line.
- The UIRSD FY21 Budget itself was up \$545,858 or 4.46% showing a 5.82% assessed increase (see 12/5/19 Minutes p.2-3).
- ROXANNE ACKERMAN MOVED TO REQUEST THE MARTHA'S VINEYARD STATE LEGISLATIVE REPRESENTATIVE LOBBY TO REVERT TO THE OLD EXCESS AND DEFICIENCY PROCESS; THERE WAS NO SECOND. The directive came from the Department of Elementary and Secondary Education (DESE). Others agreed the current process was unsuited to regional districts (see 3/18/19 Minutes p.4 #E).
- UIRSC members were reminded to sign the warrants.
