### Call to Order (Agenda Item #I)

The Martha's School Regional High School Committee (AISC) meeting was called to order at 6:51PM.

## **Vote: Fall Reopening Final Plan** (Agenda Item # V)

(See documents on file & 8/13/20 AISC Minutes.)

The MVRHSC commended Principal Sara Dingledy for the all-remote / in-person support hybrid plan.

- Transportation was being reconfigured using MVRHS buses, and Vineyard Transit Authority (VTA) runs.
- At this point expenditures, many of them covered by State and Federal grants, were within budget parameters (including the Contingency Line): tents (not trailers at this time), wiring and wifi, and personal protective equipment (PPE), student technology devices.
- The hard date for re-evaluation was set at the end of the first quarter. Assessment factors were:
- whether there were new testing/protocols to allow full in person learning,
- Plan success including student specific data,
- whether there was a more educationally sound alternative.
- Prin. Dingledy did not expect significant staff changes. The Martha's Vineyard Educators Association (MVEA) was part of the process. Union contract negotiations were needed.
- A member of the public asked about wastewater testing.
