I. Call to Order

The Martha's Vineyard Regional High School Committee (MVRHSC) meeting was called to order at 4:06 PM. II. Approval of FY22 Re-certified Budget

Health and dental premiums were increased 2-3% for FY22, but the Cape Cod Municipal Health Group (CCMHG) voted to provide a one-time one-month premium holiday. CCMHG will provide twelve months of coverage for eleven months of payments.

Decreases to the MVRHS budget, including Shared Services:

- Medical insurance decreased by \$248,450.
- Dental insurance decreased by \$4,492.
- Shared Services decreased by \$2200.
- There was a recommendation to the Committee to decrease SPED Director's line-item salary by \$13,491 due to the restructuring of the SPED Director's position next year.
- The total decrease from the previous certified budget is \$268,638.05, and there is an increase of 2.25% to the Assessed budget for FY22.

• There was a discussion regarding the consolidation of the SPED Director's position and salary.
