II. Policy

<u>A. 2nd Reading – Martha's Vineyard Public Schools (MVPS)/Tisbury School Mask</u> <u>Policy Amendment</u> (See documents on file.)

The Department of Elementary and Secondary Education (DESE) updated guidance required universal masking until October 1, 2021.

• ON A MOTION DULY MADE BY MR. MICHAEL WATTS AND SECONDED BY MS. AMY HOUGHTON THE TISBURY SCHOOL COMMITTEE UNANIMOUSLY (2 AYES, 0 NAYS, 0 ABSTENTIONS: MR. WATTS—AYE, MS. HOUGHTON—AYE) APPROVED THE SECOND READING OF THE MARTHA'S VINEYARD PUBLIC SCHOOLS/TISBURY SCHOOL MASK POLICY AMENDMENT.

<u>I. Approval of Tisbury School Project Owners Project Manager (OPM) and Architect/</u> <u>Designer Contracts</u> (See documents on file.)

Tappé Architects and CHA both reviewed their estimates and were able to reduce their service costs by ~ \$273,000. However construction costs, in particular materials and permitting, revised the total project estimate to \$52,777,880.

- All other contract language was deemed to continue.

- Noting this contract as Town responsibility, TSC reviewed the original Town procurement and bid process.

- AMEND/EXTEND THE TAPPÉ ARCHITECTS, INC. CONTRACT FOR ONGOING SERVICES THROUGH THE COMPLETION AND CLOSEOUT OF THE TISBURY SCHOOL PROJECT FOR A PRICE NOT TO EXCEED \$4,071,920, AND

- AMEND/EXTEND THE CHA CONSULTING, INC. (PREVIOUSLY DAEDALUS PROJECT, INC.) CONTRACT FOR ONGOING SERVICES THROUGH THE COMPLETION AND CLOSEOUT OF THE TISBURY SCHOOL PROJECT FOR A PRICE NOT TO EXCEED \$1,414,230.
