#### Call to Order:

The meeting of the Martha's Vineyard Regional High School School Committee (MVRHSSC) was called to order at 12:08 PM by Chair Amy Houghton. The meeting was recorded; video cameras were asked to be turned off except for MVRHSC members or Administrators or when actively participating; attendees were asked to identify themselves with first and last names. ### Track and Field Project; Rescind and Re-vote Counsel

SKIPPER MANTER MOVED TO RESCIND THE AUTHORIZATION TO HIRE ATTORNEY MARK BOBROWSKI OF BLATMAN, BOBROWSKI, HAVERTY & SILVERSTEIN; KRIS O'BRIEN SECONDED. MOTION PASSED UNANIMOUSLY: 9 AYES, 0 NAYS, 0 ABSTENTIONS. MS. ACKERMAN—AYE, MS. HOUGHTON—AYE, MS. KIRK—AYE, MR. LIONETTE—AYE, MR. MANTER—AYE, MS. O'BRIEN—AYE, MR. PACIELLO—AYE, MS. SHERTZER—AYE & MR. WATTS—AYE.

Members discussed the issues and urgency of meeting the deadline of June 3, 2022 to file the appeal. (Please see document on file for details: Minutes MVRHS SC May 23 Special Meeting.pdf, pg 3, Special Counsel, para 2)

Concerns were raised that new counsel had not been identified; time was of the essence; transparency of the process was important; a realistic estimate should be set, a financial amount acceptable for the process.

Kimberly Kirk said she had just spoken with School District Counsel Peter Sumners of Murphy, Lamere & Murphy, PC; he advised using the firm Mead, Talerman & Costa, LLC, which would have the same terms and hourly rate of Attorney Mark Bobrowski Of Blatman, Bobrowski, Haverty & Silverstein; the conflict of interest check had been completed.

#### Comments/Others:

Samuel Hart clarified that he expressed his point of view as one MVRHS administrator. He was concerned the collateral damage from this appeal process could impact the momentum as the towns were coming together for The Massachusetts School Building Authority (MSBA) process. Was the victory in the moment worth the cost to the larger picture?
