#### Call to Order:

The meeting of the Martha's Vineyard Regional High School School Committee (MVRHS SC) was called to order at 5:03 PM by Chair Robert Lionette. The meeting was recorded; video cameras were asked to be turned off except for MVRHSC members or Administrators or when actively participating; attendees were asked to identify themselves with first and last names. (Recorder's Note: Discussions are summarized and grouped for clarity and brevity).

#### Welcome - Chair:

(Agenda Item #I) Chair Lionette thanked everyone for attending. He appreciated the push back from his colleagues in filling the Building Committee (BC) roster and for slowing down and broadening the selection.

#### **Building Committee - Vote**

(Agenda Item #II)

Samuel Hart screen shared the document that detailed the 25 names and/or placeholders; he indicated this list would satisfy the The Massachusetts School Building Authority (MSBA) requirements. There were four boxes:

- 1. School Administration Required by MSBA (4)
- 2. Recommended by Town Select Boards (13)
- 3. Recommended by School Administration (6)
- 4. Member(s) of School Committee (2)

Mr. Hart said they were nominating positions not people and explained the rationale for those included. Placeholders could be filled at a later date; members would come and go as this was a multi-year commitment; the larger committee could be broken down into sub-committees to be more workable and manageable. Principal Sara Dingledy said this was done very thoughtfully to be inclusive and representative of the student body.

### Discussion:

- The size of this committee was too large for it to be a functional group; concerns were expressed of it being dysfunctional before it even began; alternates were reviewed as a possibility.
- Mr. Hart said the MVRHS SC had the power to add or subtract membership of the BC, the MSBA needed a 20-day notification of any changes.
- Members were frustrated with the timing and process to date; they recommended reaching out to Attorney Nancy Campany, she had the necessary experience to guide this process on committee formation and size, as well as its voting structure.
- A placeholder for teacher/union position would be added.
- A recommendation to include Dhakir Warren, Executive Director of the MV Boys & Girls Club was made.
- Members were uncomfortable making changes to the town selections put forth by the Select Boards and strongly recommended acceptance.
- Superintendent Richard M. Smith said proper representation from the towns was important and to trust their decisions; those members would be the public spokespersons for the project.
- Members recommended approval of the group as presented and to let the BC determine how it would move forward. Categories would need to be maintained but the players could change; they could limit themselves as needed if the group size wasn't working.
