Call to Order (Agenda item #I)

The Up-Island Regional School Committee (UIRSC) meeting was called to order.

Chilmark School Projects – Updates (Agenda VI)

- 19 of the 33 windows and the cracked door had been replaced. Painting would follow, with a completion goal of mid-August.
- So far there were no bids on the front entrance doors, however Owners Project Manager (OPM) CHA/Daedalus was negotiating with contractors.
- Heating/Ventilation/Air Conditioning (HVAC) Project—(See Minutes: 10/18/04 p.1-2 #VII, & 5/31/05 p.3-4 #II, & 12/19/22 p.2-4 #IV D, & 4/13/23 p.4-5 # 1 & IV C, & 5/15/23 p.1 #III B.) In general the project was going very well, on time and on budget.
- The site was fenced but the OPM was negotiating price for interior and exterior separations to support the 40-50 preschool and summer program children.
- Attic equipment/piping was demolished and removed. The carpentry crew was cutting the gable end access panels.
- Chilmark Town representative Billy Dillon was on site 6 hrs./week and would be paid out of the project contingency.

Chilmark Special Education (SpEd) Co-Teacher – Vote Will Take Place

(Agenda Item #III) (See 4/13/23 Minutes p.3-4 #III B2.)

The School was awarded a grant for half of a full-time SpEd co-teacher. Consequently, Head of School Susan Stevens proposed modifying the previous contingency fund vote to cover half the co-teaching salary and only 1 Education Support Professional (ESP). The position, including benefits, was estimated at \$93,000; a shortfall of \$6,600 would be found in the Fiscal Year 2024 (FY24) Budget. This would result in 2 teachers and one ESP covering 2 classrooms. Skipper Manter voiced his usual objections to the contingency fund formula.

A West Tisbury School (WTS) employee insurance encumbrance error left a \$38,287.12 shortfall in the June transfer vote (see 6/20/23 Minutes p.3-4 #IV B). The proposal was to cover it from the regional Contingency line in time for the July 15th FY23 closing deadline. The contingency was very close to the correct standard formula and well within the 80/20 WTS/Chilmark School split. Mr. Manter still objected to the use of contingency as inappropriate.
